Key result highlights
Expansion in the transmission network and rise in power distribution volumes delivered revenue growth

Adani Transmission Ltd (ATL) reported QoQ/YoY revenue growth of 3.8%/27.9%, respectively, to INR 3,252 cr in Q2FY23. ATL's power transmission revenue grew at a QoQ/YoY rate of 3.9%/10.1%, respectively, to INR 868 cr Q2FY23. The company's power distribution business recorded QoQ/YoY change of -2.2%/+28.0%, respectively, to INR 2,164 cr during the quarter.

The power transformation capacity improved from 33,141 MVA in Q2FY22 to 40,001 MVA in Q2FY23, while the operational transmission line network expanded from 18,336 ckm in Q2FY22 to 18,795 ckm in Q2FY23.

Power distribution volumes grew at a QoQ/YoY rate of 35.9%/25.7% respectively to 2,560 mn units on account of a significant rise in commercial and industrial segment demand and contribution from MPSEZ Utility Ltd (MUL). The total distribution network on MUL is around 100 km, comprising 75 km underground and 25 km overhead network. MUL distributes around 200 mn units, with distribution losses of 3%-4%. The load at MUL's distribution area is expected to grow, as more industrial and commercial activities get added in its geography of operations in the coming years.

Significant surge in energy prices and net loss in regulatory deferral account impacted profitability

EBITDA grew at a QoQ/YoY rate of 2.4%/7.0% to INR 1,237 cr in Q2FY23, while EBITDA margins contracted by 54bps QoQ and 744bps YoY to 38.0% during the quarter. Net impact of INR 73 cr due to the net loss in regulatory deferral account balances impacted the operating performance.

Finance cost changed at a QoQ/YoY rate of -3.5%/+32.1% respectively to INR 398 cr which resulted in the QoQ/YoY change of +11.5%/-26.8% in net profit to INR 207 cr during the quarter.
